This AGREEMENT, made and entered into, by and between the City of Dunedin, a Florida municipal corporation (hereinafter referred to as "City"), and _____

_____ (hereinafter referred to as "Member(s)"), do hereby for and in consideration of the mutual promises and covenants herein made and agreed to be kept, and in consideration of the payment of money as is otherwise set forth hereinafter, do hereby agree as follows:

1. This Agreement shall be deemed to be a use agreement, effective as of _____
_____, at the Dunedin Golf Club ("DGC") as is otherwise set forth herein, and is otherwise reflected in the policies and procedures governing conduct at the DGC as promulgated by the City Manager or his/her designee.

2. The Member shall pay user fees as outlined herein, subject to increases or decreases from time to time, with or without notice, as is determined by the City Manager or his/her designee. These fees include, but are not limited to, initiation fees, membership dues, cart fees, storage fees, and food and beverage minimums. **The Agreement shall be automatically modified to reflect such increased user fee.**
3. All fees are to be paid in advance or before the first day of each month. If full payment is not received by the 15th day of the month, a delinquency charge will be assessed to any unpaid balance of the payment greater than \$25.00. The delinquency charge will be equal to 10% of the unpaid balance of the payment. In the event a user fee is delinquent after 30 days from the 1st of the month, the membership is subject to immediate suspension and all privileges will be revoked.
4. The initiation fee and the first month's fees will be paid at the time of the signing of this Agreement. If a waiting list fee has been previously paid, it shall be credited against the amount due. The initiation fee is non-transferrable and non-refundable.
5. This Agreement shall at all times be subject to cancellation by the City as is otherwise hereinafter set forth and shall be subject to change of policy at any time as determined by the City for the conduct of operations at the Dunedin Golf Club. **The City reserves the right to terminate this Agreement, with or without cause, in its sole discretion.**
6. The Member agrees to abide by all policies and procedures of the Dunedin Golf Club.
7. Dunedin Golf Club, golf course and facilities will be maintained to allow for normal golf activities. There is no guarantee as to the condition of the course or any amenity included in this membership. Members will have access to amenities listed in this agreement subject to availability, which is to be determined at the sole discretion of the City. Certain private and public events may dictate that the golf course, practice areas, restaurant and/or other areas of Dunedin Golf Club be closed. Member understands and agrees that nothing in this Membership

Agreement shall entitle member to any of the facilities on any particular day nor to any discount or refund on account of any limited access.

8. The Member(s) hereby hold(s) the City harmless from any liability that might arise because of the loss of life, bodily injury, property loss, or property damage which may occur to him/herself, his/her family, guests, invitees, or his/her or their property, or to the property of others arising from the Member's use of the Dunedin Golf Club hereunder during the term of this Agreement. I/We hereby release, absolve, commit not to sue, and discharge the City of Dunedin, its commissioners, mayor, officials, officers, directors, agents, servants, employees, volunteers, representatives, attorneys, and/or any other person, firm or corporation charged or chargeable with responsibility for recreation and event activities, acting within the course and scope of their employment or duties, from any liability, claims, demands, or damages of any kind, including but not limited to personal injury, illness (including but not limited to exposure to COVID-19), bodily injury, death, and/or property damage arising out of any loss or injury resulting from my/our child's participation in any activities and events conducted by the City of Dunedin.
9. This Agreement shall continue in full force and effect until cancelled or amended as is otherwise provided herein. This Agreement may be cancelled, changed, or amended by the City without notice or without cause effective as of the first day of any calendar month except as in terms provided herein. **The Member shall furnish 30-day written notice to the General Manager of Golf Operations of the City of Dunedin of his/her intent to terminate this Agreement.**
10. This Agreement is not assignable or transferable in any manner whatsoever by the Member to any other person.

I/We are executing this release by electronic signature technology and such electronic signature shall act as my/our legal signature(s) on this release and shall be treated in all respects as an original, handwritten signature.
